WOMEN SEEKING ASSISTANCE WITH SUBSTANCE ABUSE CAN ENTER THE HIGHER GROUND PROGRAM. THIS PROGRAM IN INDIANAPOLIS FOCUSES ON TOTAL LIFE CHANGE, RATHER THAN A SINGLE FOCUS ON THE ADDICTION. CURRICULUM INCLUDES RECOVERY CLASSES, COUNSELING, AND LIFE SKILLS CLASSES.

OUR SERVICES TAKE A HOLISTIC APPROACH BY PROVIDING PHYSICAL, MENTAL, EMOTIONAL, AND SPIRITUAL HELP. HUNDREDS OF WOMEN AND CHILDREN ENTER OUR DOORS SEEKING FOOD, CLOTHING, AND HOUSING. THESE WOMEN FIND THESE VITAL NEEDS SUPPLIED, BUT THEY ALSO EXPERIENCE LOVE AND COMPASSION, BRINGING REST FOR THEIR WEARY SOULS.
