BREAKFAST, LUNCH, DINNER, SHOWERS, CLOTHING, DAY ROOM, CHAPEL SERVICES, AND CASE MANAGEMENT (WITH REFERRALS TO ONSITE AND OFFSITE SOCIAL SERVICE AGENCIES) ARE PROVIDED. MEDICAL SERVICES ARE ALSO AVAILABLE.

THE HEBRON PROGRAM, FOR MEN, IS LOCATED ON A 288-ACRE SITE IN MONROE COUNTY. THE HIGHER GROUND PROGRAM, FOR WOMEN, IS LOCATED ON A RESIDENTIAL SITE IN INDIANAPOLIS. THESE PROGRAMS FOCUS ON TOTAL LIFE CHANGE THROUGH A RELATIONSHIP WITH CHRIST, RATHER THAN A SINGLE FOCUS ON THE ADDICTION.
